 - (c) The recipient shall be an applicant who has been accepted for a regular course of study, or a student presently attending college at the undergraduate level, or technical or vocational school.
 - (d) Students may reapply for this scholarship each year that they are undergraduate students.
2. The award will be given during a worship service of the Peapack Reformed Church. The recipient is expected to attend the award service.
 3. All information, including application form, transcript, and three letters of recommendation must be submitted in one packet by Monday, May 7, 2018. The information is for the exclusive use of the Scholarship Committee. It must be addressed to the Arntz Scholarship Committee Chairperson, Peapack Reformed Church, Box 253, Gladstone, New Jersey, 07934, and be delivered to the church by Monday, May 7, 2018 or postmarked no later than Monday, May 7, 2018.
 4. If the packet is delivered late, postmarked after Monday, May 7, 2018, or if it is not properly and fully completed, then the candidate will not be considered for the Scholarship.
